## Notice Regarding Executive Appointments after the Transition to a Company with an Audit and Supervisory Committee Governance

## **Structure**

As separately disclosed in the "Notice Concerning the Transition to a Company with an Audit and Supervisory Committee Governance Structure" dated November 6, 2015, WirelessGate has resolved to make the transition to a company with an audit and supervisory committee governance structure after it is approved by WirelessGate's 12<sup>th</sup> Annual Shareholders Meeting to be held on March 25, 2016 (hereinafter referred to as the "Annual Shareholders Meeting"). In this regard, WirelessGate is pleased to announce that at the meeting of its Board of Directors held today, the officers after the transition to a company with an audit and supervisory committee governance structure were informally appointed as follows.
